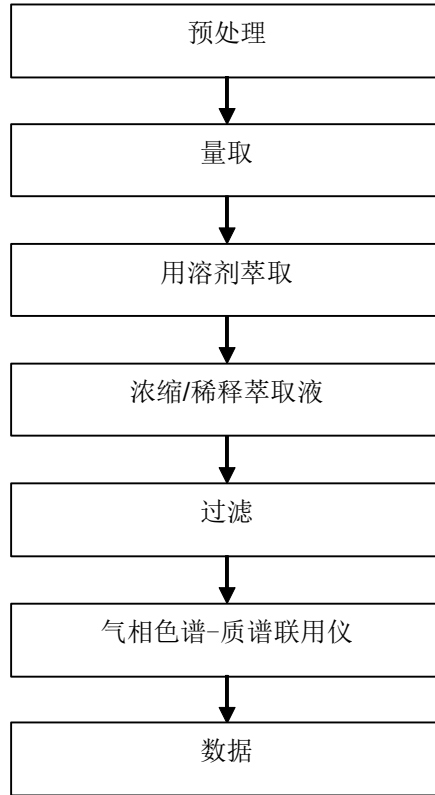

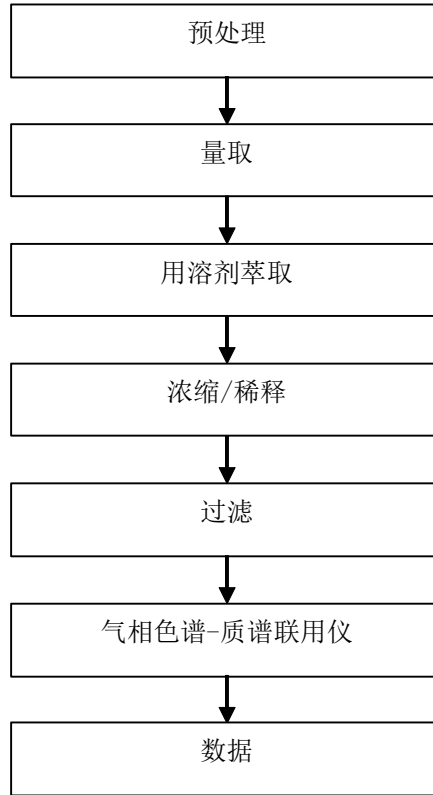
PBBs/PBDEs 测试流程图

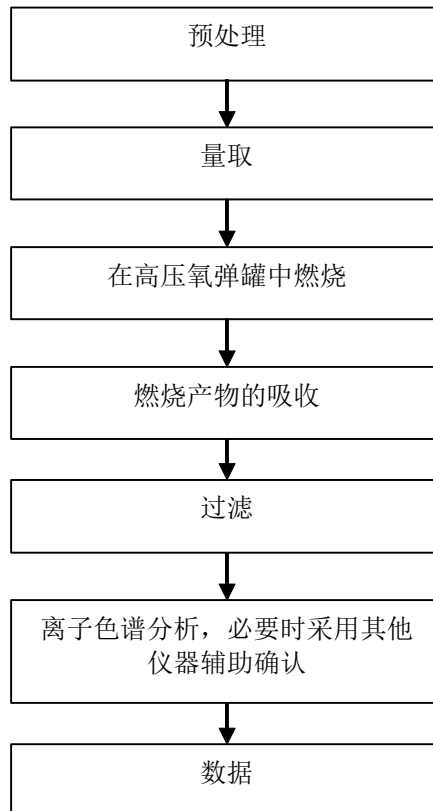
Phthalates 测试流程图

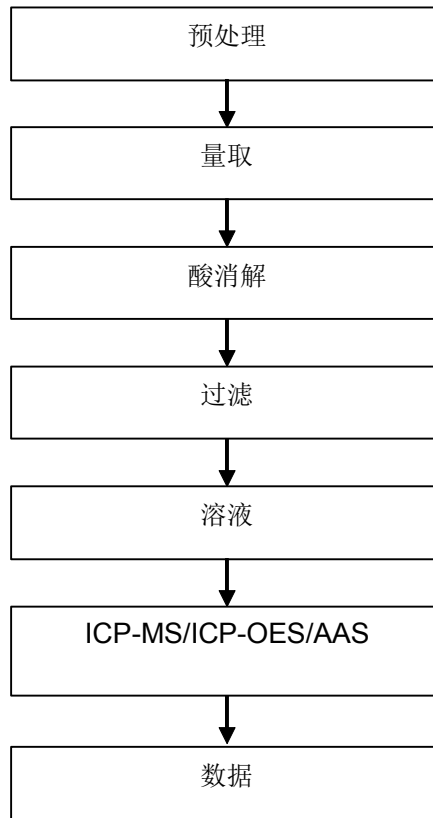
Halogen(氧弹法)测试流程图

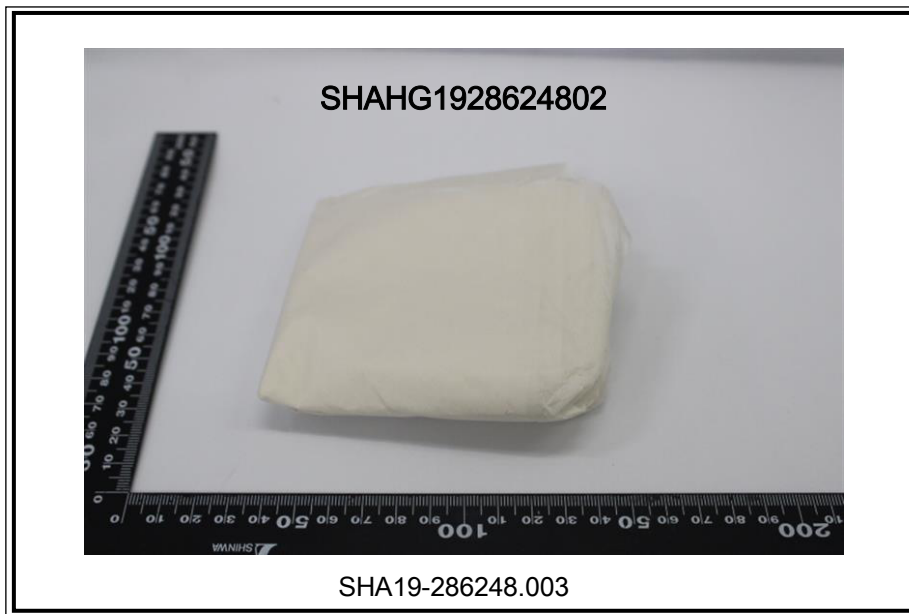

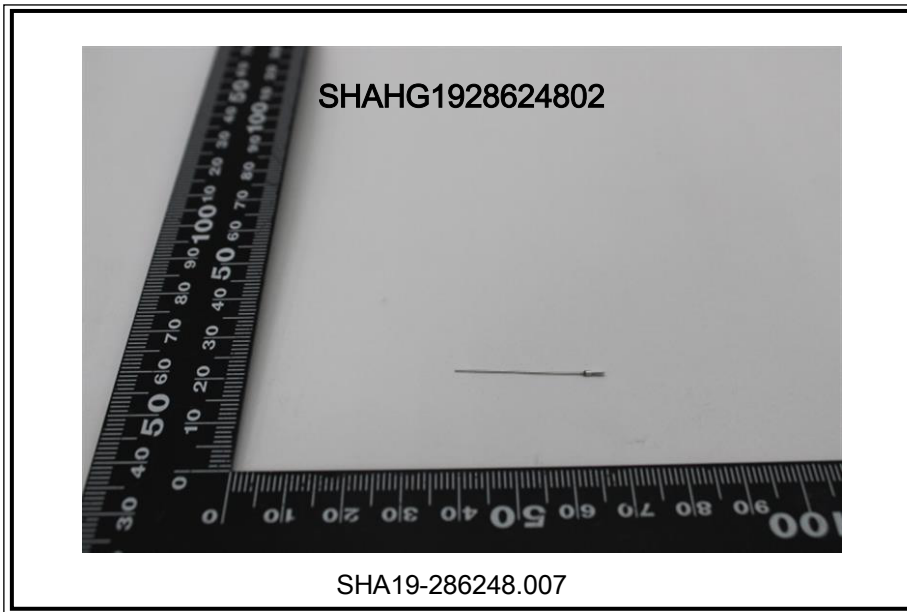
